# Virtua Structural Heart Team Expands Use of MitraClip in Heart Failure Patients with Functional MR

On Monday, April 19, the Structural Heart team at Virtua Our Lady of Lourdes Hospital successfully performed its first two MitraClip procedures for functional (or secondary) mitral regurgitation on patients with heart failure.

First approved by the FDA in late 2013 for severe, symptomatic primary mitral regurgitation, Abbott's MitraClip remains the only transcatheter mitral valve repair (TMVR) device on the market. Operators perform edge-to-edge repair by using the device to clip together the leaflets of the mitral valve.

Recently, CMS extended Medicare reimbursement for TMVR to include functional mitral regurgitation resulting from heart failure, according to a <u>revised National Coverage Determination</u> (NCD). Functional MR may occur in patients with heart failure and left ventricular dilatation. Severity of functional MR is strongly associated with decreased quality of life, increased rates of hospitalization for heart failure, and shortened patient survival.

Both patients had a severely diminished ejection fraction with severe MR. The team, led by Ibrahim Moussa, DO, FACC, FSCAI, RPVI, implanted a single clip (the new and improved MitraClip G4) in each patient, which reduced the severity of the MR to mild. Both patients went home the following day.

"A lot of hard work went on behind the scenes to reach this milestone," said Dr. Moussa "I want to congratulate and thank the team and administrative staff for making this important therapy available to our heart failure patients. I also want to thank Dr. Harry South and Dr. Jeff Namey for referring the two patients."

## Virtua Now Offering Breakthrough Lung Treatment for Severe Emphysema

Pulmonary specialists at Virtua are now offering Bronchoscopic Lung Volume Reduction (BLVR) with endobronchial valve (EBV) placement for patients with severe emphysema and COPD. This FDA-approved, minimally invasive procedure is used to treat end-stage COPD and advanced emphysema.

"This is such a big moment for members of our community who have been living with significant breathing issues," said Virtua thoracic surgeon Matthew Puc, MD, who, along with interventional pulmonologist Syed Riaz, MD, are now providing this service as part of a multidisciplinary team. "With this advanced procedure, we're able to improve lung function by precisely targeting damaged areas. We're beyond excited to have this tool in our armamentarium as it will certainly and positively impact our patients' quality of life."

The procedure takes roughly 30 to 60 minutes to complete. During that time, a small scope is guided to insert endobronchial valves into the patient's hyperinflated lobes, allowing trapped air to escape and preventing air from re-entering. This essentially allows the healthier areas of the lungs to work more effectively.

"This benefits of this approach include fewer side effects, less pain, and a shorter hospital stay," said Dr. Riaz. "Post-procedure, patients typically stay in the hospital for three days per expert consensus, barring complication."

It's important to note that this procedure is not curative. It does, however, fundamentally improve patients' quality of life and enables them to take bigger, fuller breaths. To learn more about Virtua's comprehensive lung program, click <a href="here">here</a>.

## April 27 – Go Live Date for ADT Requirements for Cures Act

**Tuesday, April 27**, is the next Cures Act milestone as regulations take effect involving Admission, Discharge, and Transfer (ADT) notifications. While May 1 is the national deadline for going live on the ADT Event Notifications requirements, Virtua plans to be in accordance with the mandate a few days earlier.

The new rule requires hospitals to share electronic ADT event notifications with certain other providers so that the care teams have the most up-to-date and accurate information about their patients. The goal is to help monitor patients throughout the entire continuum of hospital care to improve outcomes while reducing preventable readmissions.

Virtua has been sending admission and discharge communication to primary care providers prior to this mandate. As an organization, we are revising the communication for clearer identification by other providers when their patient is treated at a Virtua hospital (i.e. adding the Virtua logo/hospital name to all communication, including InBasket messaging). All other hospitals in our area should be following the mandate as well. As a provider, you may be seeing ADT notifications from any hospital that treats your patient.


**In related Cures Act news**, the Office of the National Coordinator for Health Information Technology (ONC) recently issued new guidance on the timing of the release of test results to a portal. Virtua is working through this new information and will notify clinicians of any changes to our current process in the very near future.

Meanwhile, we encourage clinicians to continue having the conversation with patients around the availability of results through MyChart, and the possibility that they may receive results sooner than they may expect or before the provider receives the result. Patients should be assured that there is a process in place if test results are critical. For inpatients, the patient's nurse or testing department ensures providers are notified after any critical results. As a reminder, clinicians may "unshare" a note, or delay the release of a result, in only two scenarios:

- 1) To prevent harm, when the sharing of information to MyChart is reasonably likely to endanger the life or physical safety of the patient or another person, or
- 2) If the patient (or his/her legal representative) has specifically requested that the note not be shared to his/her MyChart

In February, Virtua went live with the implementation of the key components of the 21st Century Cures Act, well ahead of the national mandate of April 5. We will continue to provide updates as various elements of the Act go into effect and guidance if further refined. Via <u>Digital 411</u>, Virtua has created a special <u>Cures Act Resource link</u>. ## **Update on Pause for Johnson & Johnson Vaccine Administration**

The Advisory Committee on Immunization Practices (ACIP) prepares to meet again **tomorrow**, **April 23** about the pause on the use of the Johnson & Johnson vaccine.

ACIP, which provides guidance to the federal Centers for Disease Control and Prevention (CDC), met on April 14 following a recommendation by the CDC and the Food and Drug Administration (FDA) to

pause the use of the Johnson & Johnson vaccine out of an abundance of caution upon reviewing data involving six U.S. cases of a rare and severe type of blood clot in individuals after receiving the vaccine.

Following that recommendation, the New Jersey Department of Health (NJDOH) suspended the administration of the Johnson & Johnson vaccine across all vaccination sites until further notice from the CDC and FDA.

In an appearance on <u>CNN</u> last weekend, **Dr. Anthony Fauci** anticipated the outcome of Friday's ACIP meeting. He said, "What I imagine we'll see is that they will come back with some sort of a warning or restriction... I do think that we will get [the Johnson & Johnson vaccine] back in some manner or form. But what I am sure, I hope, that we don't see anything extended beyond Friday — we need to get a decision one way or another."

In the meantime, NJDOH is encouraging residents to keep their vaccine appointments for the Moderna and Pfizer vaccines, which have been demonstrated to be safe and effective and use different technology than the method used for the Johnson & Johnson vaccine.
