#### Vaccine Mandate Update: Weekly Testing to Take Effect

Earlier this week, the U.S. Food and Drug Administration officially authorized the Pfizer-BioNTech vaccine for people ages 16 and older, making it the first coronavirus vaccine to receive the agency's full approval. In response to this news, and with consideration to some colleagues' hesitancy regarding the vaccines, Virtua has adjusted the timeline of its COVID-19 vaccine mandate.

Now, colleagues have until Wednesday, Sept. 15 to receive a first dose of the Pfizer vaccine. This ensures that all Virtua colleagues receive the full series of the Pfizer vaccine by Wednesday, Oct.
6. Those colleagues who choose to receive the two-dose Moderna vaccine must receive a first dose by Wednesday, Sept. 8. Those colleagues who choose to receive the Johnson & Johnson (Janssen) vaccine, one dose, must receive it by Wednesday, Sept. 15.

On Aug. 6, 2021, **Governor Phil Murphy** signed Executive Order 252, requiring health care workers who are not fully vaccinated to submit to weekly COVID-19 testing. Any colleague who is not fully vaccinated—including those who have received or are awaiting a medical or religious exemption—must participate in weekly COVID-19 testing.

According to the executive order, a person is deemed fully vaccinated two weeks after receiving a second dose of the Pfizer or Moderna vaccines, or two weeks after the single-dose Johnson & Johnson vaccine. The order extends to all Virtua staff, regardless of employment type or whether an individual is in a patient-facing role.

#### Details about the testing process—including a Q&A—will be available soon.

While the overwhelming majority of Virtua-affiliated clinicians have received the vaccine, we continue to ask for you to encourage hesitant colleagues to get their shots. Virtua encourages any colleague who is not yet vaccinated to make a vaccination plan right away. Virtua will offer the now fully approved Pfizer vaccine at the Barry D. Brown Health Education Center (the HEC) from 8 a.m. to 4:45 p.m. on the following days:

Monday, Aug. 30 Tuesday, Aug. 31

### Colleague Flu Vaccination Program Begins Wednesday, Sept. 1

Flu vaccine season is fast approaching. Help protect our patients, visitors, and yourselves from the flu by getting a flu vaccination, especially as we continue to navigate through COVID-19.

Flu shots are mandatory for all Virtua colleagues. Virtua will begin offering free flu shots on **Wednesday**, **Sept. 1**. All colleagues should receive their flu shots by 11:59 p.m. on **Tuesday**, **Nov. 2**.

Please note the following changes to this year's program:

- There will be tented outdoor clinics to enable social distancing, as well as indoor flu clinics as long as social distancing requirements are still met and maintained.
- Virtua Medical Group (VMG) colleagues will continue to be directed to receive their flu shots from designated practice extenders, coordinated by VMG leadership.
- Corporate colleagues who are working offsite can attend any of our flu clinics or can choose to receive the flu vaccine at their primary care practice locations or a CVS Minute Clinic, where colleagues with Virtua medical coverage can obtain flu vaccinations at no cost.
- All colleagues who receive their flu shots outside of Virtua must scan and email proof of vaccination with the following information to <u>flu@virua.org</u>:
  - Colleague Name
  - Colleague ID Number
  - Date of Vaccination
  - Vaccine Lot Number
  - Vaccine Expiration Date
  - Administered in Left/Right Arm
  - Who Administered the Vaccine
  - Location of Vaccine Administration
- Instructions to apply for a medical and religious exemption/accommodate requests may be found on the VINE under the "Colleague Flu" button.

# Latest COVID-19 Fast Facts

- Sadly, yesterday marked the first time since May that COVID-19 hospitalizations in New Jersey rose surpassed 1,000. According to the New Jersey Hospital Association, the resurgence is a result of the Delta variant, which is now the dominant strain in our state.
- The rate of transmission in New Jersey is now 1.17.
- The total number of cases as of 3 p.m. are as follows:
  - Burlington County: 40,755 cases
  - Camden County: 51,944 cases
  - Gloucester County: 28,294 cases
- COVID-associated mortality for Camden, Burlington, and Gloucester counties: 2,690.
- The state's Vaccination Overview dashboard reports 11,005,193 doses of vaccine have been administered.

AHA Recognizes Virtua Our Lady of Lourdes Hospital and Virtua Emergency Medical Services Virtua Our Lady of Lourdes Hospital has received the American Heart Association's (AHA) **2021 Gold Plus Get With The Guidelines-Heart Failure Quality Achievement Award** for our commitment to caring for patients living with heart failure.

The award recognizes Virtua's commitment to ensuring people with heart failure receive the most appropriate treatment according to nationally recognized, research-based guidelines founded in the latest scientific evidence. The goal is speeding recovery and reducing hospital readmissions for heart failure patients.

"We are dedicated to improving the quality of care for our patients with heart failure by implementing evidence-based guidelines, including medications, attention to diet and exercise, and implantable internal defibrillators and monitoring devices such as CardioMems," said **Theresa Rowe**, director of the Virtua Heart Failure Program. "The end goal is to ensure more people in South Jersey can experience longer, healthier lives."

"We are pleased to recognize Virtua for their commitment to heart failure care," said Dr. Clyde W. Yancy, national chairperson of the AHA Heart Failure systems of care advisory group and chief, division of cardiology at Northwestern University, Feinberg School of Medicine. "Hospitals that follow Get with the Guidelines protocols often see fewer readmissions and lower mortality rates—a win for health care systems, families, and communities."

Virtua Our Lady of Lourdes also received the association's **Target: Type 2 Honor Roll award**. To qualify for this recognition, hospitals must meet quality measures developed with more than 90% of compliance for 12 consecutive months for the "Overall Diabetes Cardiovascular Initiative Composite Score."

Additionally, Virtua Emergency Medical Services (EMS) received the AHA Mission: Lifeline EMS Gold Achievement Award for implementing specific quality improvement measures to treat patients who suffer severe heart attacks.

Each year, more than 250,000 people experience an ST elevation myocardial infarction (STEMI), the deadliest type of heart attack, caused by a blockage of blood flow to the heart that requires timely

treatment. To prevent death, it is critical to restore blood flow as quickly as possible, either by mechanically opening the blocked vessel or by providing clot-busting medication.

The AHA's Mission: Lifeline program helps reduce barriers to prompt treatment for heart attacks starting from when 9-1-1 is called, to EMS transport and continuing through hospital treatment and discharge. Optimal care for heart attack patients takes coordination between the individual hospital, EMS, and health care system.

"Virtua is honored to be recognized by the AHA for our dedication to providing optimal care for heart attack patients," said **Jim Newman**, assistant vice president of Virtua EMS. "The Mission: Lifeline program puts proven knowledge and guidelines to work on a daily basis so patients have the best possible chance of survival."

### Virtua Honored as a Best Employer by Forbes
