#### **Booster Shot Now Requirement for Virtua Colleagues**

Today Virtua's EVP and Chief Clinical Officer Reginald Blaber, MD, FACC sent a message to all colleagues announcing that Virtua Health has added the requirement of a booster vaccine for Virtua colleagues and contractors covered by the booster mandate contained in New Jersey Executive Order 283 (EO 283). He noted that "while the Executive Order excludes certain employees, such as those working remotely or in the corporate offices, we strongly encourage a booster shot for all colleagues."

Dr. Blaber wrote, "As we near the second anniversary of the global pandemic disrupting our lives, the magnitude of our role as a major health system committed to the values and purpose of being *Here for* 

*Good* has grown even more meaningful. Never wavering from our calling and responsibilities, we have kept our patients and our community at the center of our actions and have prioritized the safety and wellbeing of our workforce at every step.

"The CDC has reported that vaccinated people who receive a COVID-19 booster are likely to have stronger protection against contracting and transmitting COVID-19, and stronger protection against serious illness, including hospitalizations and death. Our own experience at Virtua over the past six weeks is in line with a recent study published in *The New England Journal of Medicine*: severe illness and death were notably lower among those who were boosted than those who only completed the first series.

"To ensure that we continue to follow the science and do everything possible to protect our colleagues and our patients, we are adding the requirement of a booster shot for Virtua colleagues and contractors covered by the booster mandate contained in New Jersey Executive Order 283 (EO 283). While the Executive Order excludes certain employees, such as those working remotely or in the corporate offices, we strongly encourage a booster shot for all colleagues.

"Specifically, EO 283 obliges health care settings to require workers to provide proof that they are up to date with their COVID-19 vaccinations, including having received a booster shot when eligible. This order necessitates "covered workers" (all employees and contractors, whether patient-facing or administrative) to provide proof to Virtua that they <u>have received a booster shot by Feb. 28, 2022, or</u> <u>within 3 weeks of becoming eligible for a booster dose</u>, whichever is later.

"Vaccine requirements have been long-standing in health care settings to not only safeguard the staff in a high-risk employment environment but to protect the immunocompromised and vulnerable patients they interact with. As we exceed 900,000 American deaths due to the pandemic, and as we recover from the largest surge and the worst positivity rate since the first wave of the virus, it is our obligation to follow the vaccine mandates and to play our critical part to protect the lives and health of our colleagues and patients."

# **COVID-19 Response by the Numbers**

As we close in on the second anniversary of the pandemic in New Jersey, the state hit two big vaccination milestones.

- The state passed the 90% mark for those eligible having at least one vaccination shot.
- The state passed the 50% mark for those eligible getting their booster.
- Additionally, the rate of transmission—the rate at which COVID-19 spreads—is at 0.5, or well below the desired 1.0 or smaller line.

Gov. Phil Murphy announced these numbers at his COVID briefing this week with a sense of caution.

"Even with these dropping numbers, none of us are yet at a point where we feel totally comfortable," he said. "We saw last winter how the numbers can quickly turn back around, and we do not want to test that theory with omicron. So, we have to remain on an extremely vigilant footing."

However, the governor continued to be optimistic, reporting that hospitalizations are two-thirds below the omicron peak of 6,089 on Jan. 11.

At Virtua, the metrics are trending in an encouraging direction as well. We have had a 65% decrease in COVID-positive patients since Virtua's peak on Jan. 11.

Kudos to the long-term care teams for safeguarding our residents and patients through the omicron surge.

Thanks also to Virtua's Dr. Sam Weiner, who participated in Camden County's virtual COVID-19 update alongside county officials. The update touched upon testing clinics, school operations, vaccination rates, and more.

"I think we are at a place where we can finally take a sigh of relief," Dr. Weiner said. "Outside our hospitals, we are seeing a decrease in the number of symptomatic patients coming into our urgent care centers and primary care offices. It is such welcome news."

### Public Health Officials Emphasize Importance of COVID Vaccines for Children


Data from the New Jersey Department of Health shows that just over 25% N.J. children ages 5 to 11 are fully vaccinated against COVID. Even though the latest COVID wave is diminishing, pediatricians and public health officials stress the importance of protecting young people through vaccination. This is, in part, because a new COVID variant could quickly emerge and, in part, because Gov. Phil Murphy stated his intention to lift mask requirements in schools beginning in March.

In regards to underwhelming pediatric vaccination participation, Dr. Mike Cascarina, president of the New Jersey Academy of Family Physicians, said, "There is this large undercurrent of vaccine hesitancy among the young... not young children, but young parents."

Dr. Melissa Stockwell, pediatrician and Chief of the Division of Child and Adolescent Health at Columbia University's Vagelos College of Physicians and Surgeons, said many parents are taking a wait-and-see approach, but that "more than 8 million children in this country got at least one dose so far, and that's a really good data set... We now have more experience with this vaccine than so many others."
