Virtua's Rectal Cancer Program Receives Prestigious Accreditation


Virtua's Rectal Cancer Program is now recognized as a National Accreditation Program for Rectal Cancer (NAPRC). Virtua's program is one of less than 60 in the U.S. to qualify for this prestigious American College of Surgeons accreditation; and one of two in New Jersey.

To achieve NAPRC accreditation, a rectal cancer center must demonstrate compliance with the NAPRC standards addressing program management, clinical services, and quality improvement for patients.

Centers are required to establish a multidisciplinary rectal cancer team that includes clinical representatives from surgery, pathology, radiology, radiation oncology, and medical oncology.

"The NAPRC accreditation is confirmation of our team achieving the highest standards of rectal cancer treatments and care," said Avi Galler, MD, director of Virtua's Rectal Cancer Program. "The most advanced treatment is available right here in South Jersey at Virtua—there is no need for patients to travel out of state."

Dr. Galler advises everyone to stay up to date on their colonoscopies—a test that can identify asymptomatic cases of rectal cancer at an earlier stage. He also reminds everyone that the age to begin colonoscopy testing has been changed from 50 to 45—and even younger for people with a family history of colorectal cancer. Racial Disparities in Medicare Home Health Use

Home health visits for Medicare beneficiaries declined in 2020, while patient acuity increased. People of color were less likely to have caregiver assistance. Those were among the key findings of a

<u>Commonwealth Fund analysis</u> of home health use by Medicare beneficiaries during the pandemic's first year. Researchers analyzed files containing 100% of Medicare claims for 2019 and 2020, plus a sample of Outcome and Assessment Information Set (OASIS) assessments. Key findings included:

- Medicare beneficiaries using home health decreased by 6% in 2020 compared to 2019.
- Home health visits decreased by nearly 14% while patient acuity increased.
- Beneficiaries of color were less likely to have caregiver assistance, and a higher proportion of caregivers available to beneficiaries of color needed additional training to adequately provide assistance.
- Among the highest-acuity—Latinx/Hispanic and Asian American beneficiaries—hospitalizations were higher when their caregivers needed training.
- The issue brief urges policymakers considering changes to the Medicare home health system to take into account observed racial disparities in access to and quality of caregiver assistance, as well as the increase in patient acuity when home health visits declined.
