An Important Video Message About the COVID-19 Vaccine

Virtua President and CEO **Dennis W. Pullin** and Virtua Infection Control Officer **Dr. Martin Topiel** share an important message about the COVID-19 vaccine.

In the video, Dennis says, "Vaccines hold the key to returning to life the way it was before. If you want to attend weddings and parties, visit family, go on vacations, or even go to dinner, vaccines will keep you safe. People are dying of COVID-19 every single day. Every life lost is a tragedy. But what makes the more recent deaths even more tragic, is that most likely, the vaccine would have led to a different outcome. You should get the vaccine because you work in health care and you know firsthand about the human suffering and the physical and emotional toll we have collectively endured."

To date, Virtua has administered more than **400,000 vaccines** to Virtua colleagues and members of our community at the Virtua Barry D. Brown Health Education Center in Voorhees, the Burlington County COVID-19 Vaccine Mega-Site in Moorestown, and other pop-up locations. We want to thank the colleagues who scheduled the thousands of appointments and the staff who worked at all locations to ensure an efficient and smooth process to vaccination. We are also grateful to the colleagues who have been ambassadors of the vaccine to their families, friends, and neighbors, raising awareness of its safety and efficacy.

In the video, Dr. Topiel says, "It's now that we must trust medical professionals, researchers, and scientists to help us through this sickness, this pandemic. These vaccines have been developed for many years, but more recently were developed to fight COVID. There was tremendous investment put into these studies up front and with great thought because people were dying by the thousands, and we needed a solution to this pandemic...We have learned how safe and effective these vaccines are. I have heard them described as a miracle. And they truly are."

Changes to the Burlington County Mega-Site Hours of Operation

Effective **Sunday, May 30**, the Burlington County COVID-19 Vaccine Mega-Site will be closed Sundays and Mondays. The mega-site will be open **Tuesday through Saturday**. The Virtua Access Center will connect with individuals who currently have second-dose appointments scheduled for Sundays or Mondays and shift their boosters to another day.

Changes to Visitation Policy at Virtua

Updated visitor guidelines are now in effect at Virtua hospitals.

For the health and safety of our patients and their families, as well as our staff and the communities we serve, **general visitation is currently limited to two visitors for each patient**. Children under the age of 18 are not permitted to visit.

Visitors must sanitize hands, participate in a temperature check, and complete a screening tool for COVID-19 symptoms upon arrival at our facilities. Facemasks are also still required for all visitors. Anyone coughing or showing other signs of illness will be kindly asked to leave and visit remotely.

General visiting hours are 8 a.m. to 8 p.m. at all Virtua hospitals.


Department-specific exceptions to the visitor guidelines include:

- Pediatric Patients Two parents/guardians can visit pediatric patients 24/7.
- **Surgery or Medical Procedure** One to two visitors may accompany the patient into the facility. The visitor(s) must depart when the patient is taken into the prep area.
- **Patients with Disabilities** Patients with disabilities, such as sensory impairment or developmental/cognitive disability, may have one to two visitors at any time.
- **High-Risk Obstetrics** One support person may accompany patients admitted for induction of labor or scheduled C-section.
- Labor and Delivery / Mother-Baby One support person may accompany laboring woman; must be same person throughout hospital stay. A doula is considered part of the patient's care team.
- **Neonatal Intensive Care Unit or Special Care Nursery** Visiting hours are 24/7 for two approved visitors (mother and designated support person/care partner).
- **Emergency Department** One visitor is permitted to be with the patient in the treatment area (regardless of time of day). Due to the changing needs of the emergency department and to preserve social distancing and privacy, visitation may be modified at any time by the emergency department staff.
- **Hospital Patients in Isolation** Visitation is not permitted for patients who are positive for COVID-19 or are under investigation for COVID-19.

In addition, visitors are **not permitted** at Virtua Medical Group offices and outpatient departments.

Free Cancer Screenings for Uninsured Residents

Free breast, cervical, colorectal, and prostate cancer screenings are available for uninsured residents who meet the following requirements:

- Resident of New Jersey
- Between the ages of 21 and 64
- Uninsured or underinsured
- Not able to pay for the screenings

The screenings are provided through the NJ CEED Program at Virtua. The program accepts Medicare Part A only. We cannot accept Medicaid per federal regulations.
