Nov. 1, 2021 – Deadline to participate in the 2022 U.S. News & World Report Best Hospitals survey


- This survey seeks your expert opinion on which hospitals are among the best at providing care for complex or challenging conditions.
- Survey-eligible physicians who are Doximity users can take the survey online next spring. <u>But</u> in order to be eligible to digitally vote for the upcoming survey, you need to claim your Doximity profile before Nov. 1.
- It's free and easy to do, and the only online platform where such voting takes place. Having a Doximity profile is also good for you professionally, as it has become the LinkedIn for clinicians.
- If you have not yet claimed your profile, you can do so now and join over 1 million health care professionals at doximity.com. Need to know how to establish your Doximity profile? Just follow the instructions here.
- U.S. News typically releases their rankings in July.

Jan. 1, 2022 – Due date to vote via Castle Connelly, the source for several "top docs" publications lists, including the coveted *Philadelphia Magazine*

- This survey identifies top physicians, rated by their peers.
- Castle Connelly is a third-party that manages physician nominations. Its online process is found at www.nominations.castleconnolly.com.
- Physicians can vote any time of the year, but voting for next year's class ends Jan. 1, 2022.

- Open to all licensed physicians (MD & DO) in America. You may nominate physicians in any medical specialty and in any part of the country. You can also indicate whether your nominee is best in the region or nationally.
- A few tips:
 - Voting is anonymous but access is granted after entering your information, including NPI number. After you submit, you will receive a nomination code to enter the site to vote.
 If you forget your NPI, it can be found here.
 - Self-nominations are not accepted.
- Philadelphia Magazine's Top Docs issue normally comes out in May.

Virtua Marlton Expands Surgery Capabilities with New Da Vinci Robotic System

Today, the Virtua Marlton operating room team performed their first procedures with the da Vinci Xi surgical system. The Xi is the latest generation da Vinci system. Virtua now offers da Vinci minimally

invasive procedures at Virtua Our Lady of Lourdes, Virtua Mount Holly, Virtua Voorhees, and Virtua Marlton. Virtua surgeon Craig Zaretsky, MD, performed the first da Vinci procedures at Marlton, two hernia repairs.

"I am excited for the expansion of our robotic platform to Virtua Marlton. With this expansion, it allows us to provide robotic services to our thoracic patient population. We already have the Monarch robotic platform to aid in the diagnosis of thoracic cancers, but now we can expand this to allow for robotic-assisted lung resections and thymectomies," said Dr. Zaretsky. "Additionally, we can expand services to our bariatric patients, which we already offer on the Mount Holly campus. Aside from these new services, we now have expanded access for our general and colorectal surgeons, which will help improve our time to surgery."

The da Vinci robot uses a high-definition 3D camera that the surgeon can move and magnify from a console located a few feet from the patient. The system directly translates the surgeon's hand, wrist, and finger movements to the robot's instruments, which are inserted into the patient through small incisions. The robot is completely controlled by the surgeon.

Compared with traditional open surgery, patients benefit from:

- Less pain
- Reduced risk for complications and infection
- Smaller incisions and less scarring
- A shorter hospital stay
- Quicker recovery
