IV Solution Shortage: Conservation Measures

Hurricane Helene caused significant damage to a Baxter production facility in North Carolina, resulting in a nationwide shortage of intravenous (IV) solutions. Fortunately for all of us and the patients we care for, Virtua Health does not source our IV solution from Baxter, and therefore we presently have stable supplies.

That said, we must always be good stewards of our resources. As such, we have implemented conservation strategies to help us manage our IV solution supply during this nationwide shortage. These measures, recommended by clinical experts and health care agencies, help to ensure products are allocated wisely to best serve our patients' needs. Hoarding or stockpiling products causes undue strain on our processes and does not reflect the Culture of WE.

Current Conservation Measures:

- 1. **Update clinical protocols**: Prioritize IV solution use for patients who are critically ill or in need of life-saving treatments.
- 2. Reserve IV fluids for patients unable to tolerate enteral hydration.
- 3. Consider enteral electrolyte replacement whenever feasible and clinically appropriate.
- 4. **Daily re-evaluation**: Assess all patients daily to determine the need for continued IV fluids.
- Discontinue KVO fluids unless necessary.
- 6. **No spiking of IV bags** unless immediately necessary.
- 7. **Utilize smaller volumes**: When clinically appropriate, use smaller IV bags or vials for reconstitution.
- 8. **No new peritoneal dialysis starts** during this period, to conserve fluids.

We continue to monitor the situation and collaborate with state and federal partners to ensure that patient care remains at the highest standard during this time. We also have formed a cross-departmental committee that meets regularly to review these matters.

Virtua Helps End Use of Race-Based Clinical Tools

Virtua is part of a coalition of 12 Philadelphia-area health systems that have stopped using race adjustments in four decision-making tools used in lung, kidney, and obstetrics care. These moves are expected to improve health outcomes for Black, Hispanic, and Asian patients.

For example:

- Black and Asian patients with lung disease will be diagnosed earlier and receive the right treatments sooner.
- Black patients with chronic kidney disease will be identified sooner, so they can get earlier treatment, including transplants.
- More kidneys will be available for transplantation, due to the removal of race from consideration in kidney donation.
- Black and Hispanic pregnant patients will have the same opportunity to have a vaginal birth after a previous C-section as others who are pregnant.

The group—called the Regional Coalition to Eliminate Race-Based Medicine—is working to remove race considerations in other clinical tools, as well.

The coalition "is doing vital work to enable all members of our communities—regardless of their race—to live healthier, longer lives," said Lisa Ferraro, SVP for Virtua and president of Virtua Our Lady of Lourdes Hospital.

Rock the Vote!

Health care is inherently political. In fact, many voters in the United States cite health care as the single most important issue when heading to the polls. This November, the Virtua workforce encourages everyone to make their voice heard by making a plan to vote -- by mail or in person -- by Nov. 5.

New legislation has established in-person early voting in New Jersey, making voting more accessible and equitable than ever before. Registered voters can cast their ballot in person at a county-designated location on **Saturday, Oct. 26 and Sunday, Nov. 3**. That's nine additional days to vote!

Burlington and Camden counties each have seven locations for early in-person voting, which will be open from 10 a.m. to 8 p.m. Monday through Saturday and 10 a.m. to 6 p.m. Sunday. Appointments are not necessary.

This expanded voting window is a fantastic benefit for health care workers with busy—sometimes unpredictable—schedules. It also offers flexibility to people in our community who have complex medical needs. In fact, *everyone* should consider voting ahead of Election Day so that a last-minute disruption doesn't derail their ability to vote.

Because this option is new, many people are unaware it exists. Be a democracy hero and spread the word among your family, friends, colleagues, and patients.

An Important Reminder: While all colleagues are, of course, entitled to their individual opinions on political candidates and policies, colleagues are <u>not</u> permitted to represent Virtua or endorse individuals/issues on Virtua's behalf, in our facilities, or otherwise on a Virtua campus or site. Nonprofit healthcare organizations are prohibited from directly or indirectly participating or intervening in any

political campaign in support of, or in opposition to, any political candidate for local, state, or federal public office. This includes any activities meant to show (or could be perceived to show) favor or opposition to one or more candidates, the distribution or the displaying of materials, or the issuing (verbal or written) of public statements made on behalf of the organization.

Federal law does allow health care providers, medical schools, and teaching hospitals to encourage their students, staff, patients, and communities to register to vote. Voter education activities are permitted as long as they are done in a nonpartisan manner.
