
COVID-19 Provider Update Friday, April 17, 2020

More Testing Access for Our Community

Virtua Health will open a coronavirus screening and testing center on the campus of Virtua Willingboro Hospital starting Monday, April 20 at noon.

The testing site, which will be available specifically to Willingboro residents or patients referred by Virtua Medical Group physicians, will be open Monday through Friday from noon until 4:00 p.m. Testing will be limited to patients who have symptoms consistent with COVID-19 (cough, shortness of breath, fever of 100°F or higher) **and** at least one of the risk factors listed below.

- Working in health care or as a first responder (EMS, fire, police, etc.)
- Residing in an institutional home-setting (group home, U.S. Armed Forces housing)
- Being 65 years old or older
- Compromised immunity
- Pregnancy
- Chronic lung disease
- Congestive heart failure
- End-stage renal disease/dialysis
- Uncontrolled diabetes
- Vulnerable household contact with someone at high risk

To assist with referral, clinicians please note:

- VMG Providers: For patients who warrant testing, call the clinician hotline at 856-246-4117. The team there will call the patient directly to arrange an appointment for testing.
- For VPP LHSHN Providers: If your patient is a Willingboro resident who warrants testing, direct them to the site where a provider will conduct a verification screening and, if appropriate, testing. No appointment is necessary as this will be handled though the "walk-up" process.

The opening comes after productive and collaborative conversations between Dennis Pullin, president and CEO of Virtua, and Senator Troy Singleton. In addition, U.S. Representative Andy Kim has also been a compelling advocate for additional testing in the county. "We were seeing an alarming number of coronavirus cases in Willingboro, significantly higher than other parts of Burlington County, and we all just knew we had to do something," said Singleton.

The make-up of the 31,000-person community includes a significant number of seniors, many retired veterans, as well as numerous commuters who travel into New York and Philadelphia, many who are essential workers. The population is also comprised of approximately 60% African Americans, which early statistics point to as being disproportionately impacted by the coronavirus outbreak.

Special thanks to Rebecca Lynch, Sarah Sivon, Dr. Sam Weiner and the VMG team rallying to establish this third ambulatory community testing site.

Clinician Webinar Highlights Plans, Clinician Engagement

On Tuesday night, more than 400 Virtua physicians participated in a network-wide Zoom meeting to learn about how we are working to address the pandemic.

Martin Topiel, M.D., Chief of Infectious Diseases, and Reg Blaber, M.D., Chief Clinical Officer, presented on our current state, proper allocation of supplies and PPE, surge plans and the collaborative efforts among the region's health systems. Chief Medical Officer, Jennifer Khelil, D.O., outlined the various executive orders that Gov. Phil Murphy has signed that are allowing hospitals to address critical staffing issues, allowing providers to extend their scope of practice and for retired physicians to join the effort, bypassing some of the normal credentialing requirements.

VMG Medical Director of Specialties and Pulmonary Medicine and Critical Care physician, Eric Sztejman, M.D., who organized and led the meeting, noted the high level of engagement and support from our providers, with clinicians who call him every day with a willingness to step up and to meet the need. He commented, "We are grateful for the hundreds of clinicians who have reached out to help. It is a credit to their commitment to our community and to our organization. We can't thank them enough."

CDC Epidemiology Study Released

In order to share the evolving epidemiology of COVID-19, the CDC has released a <u>study</u> evaluating the demographics of individuals hospitalized from COVID-19 between March 1 and March 30. The study examined all confirmed COVID-19 hospitalizations among all ages in 14 states, including New York but not New Jersey. The cohort represented about 10 percent of the U.S. population and found:

- Adults age 50 and older are much more likely (74.5 percent) to be hospitalized.
- Men accounted for 54.4 percent of hospitalizations.
- African Americans were hospitalized at a rate nearly twice as high (33%) as their overall population (18%) in the states studied.
- The overwhelming majority of hospitalized patients (90%) had one or more of the following underlying conditions: hypertension, obesity, chronic lung disease, diabetes mellitus, cardiovascular disease.
- Persons 85 or older were admitted at a higher rate for COVID-19 than for recent flu outbreaks (17.2 per 100,000 compared to 2.2 to 5.4 per 100,000).

The CDC stressed that this data is preliminary and its collection will be ongoing.
