# Latest, Local COVID-19 Testing Sites

Testing has remained a critical component of the effort to flatten the curve. Nonetheless, test availability has been limited. In our region, Virtua and regional health systems have stood up testing sites, sometimes in collaboration with each other and/or county authorities. And now, the region has its first joint collaboration between the federal government and a retail organization. No matter the host, **each site requires that the patient be symptomatic before seeking a test**. In addition, most sites have further limits, such as risk factors, residency, or occupational requirements. To sort through the options and their respective restrictions, we have organized the following list of testing sites for Camden, Burlington, and Gloucester counties. Details are provided, to the best of our knowledge, as of **May 7**, **2020**.

## **Virtua Testing Centers:**

Note that for all Virtua sites, patients are not required to bring a physical script/referral with them. The referral process is handled primarily through VMG Respiratory scheduling specialists as outlined for each center below.

**HEC (Voorhees):** Patient must be referred by a VMG or VPP or Virtua "COVID On Demand" telemedicine clinician. COVID On Demand clinicians send a task to the VMG Respiratory scheduling team who then call the patient to schedule the appointment. All other (VMG/VPP) clinicians should call our clinician hotline (856-246-4117) to get a patient scheduled.

## **Pediatric Testing**

There are no dedicated COVID testing centers for pediatric patients. Parents who call the Virtua Access Center are encouraged to speak to the child's pediatrician. If they already have and are now inquiring about where to get the test for their child, the Access Center refers callers to the county website where they live. We do know that the Burlington County testing center in Westampton will test children with an appointment.

## Telehealth

Virtua's Digital Health team is available to evaluate and refer patients for testing. Clinicians can have their patients call 888-VIRTUA-3 to access Virtua's testing algorithm and if deemed in need of testing, sent on to one of Virtua's sites.
