

LOCAL COVID-19 TESTING CENTERS (Updated July 16, 2020)

Virtua Testing Centers:

Patients are not required to present a physical script/referral at Virtua sites. The referral process is primarily handled through VMG Respiratory scheduling specialists as outlined for each center below.

Health Education Center “HEC” (Voorhees):

- Address: 106 Carnie Blvd., Voorhees

Patient must be referred by a VMG or VPP or Virtua “COVID On Demand” telemedicine clinician.

COVID On Demand clinicians send a task to the VMG Respiratory scheduling team who then call the patient to schedule the appointment. All other (VMG/VPP) clinicians should call our clinician hotline (856-246-4117) to get a patient scheduled.

- Appointment: Yes, required (no walk ups)
- Residency Requirement: No
- Age Requirement: Age 13+
- Affiliation: Virtua

New: 2600 Mount Ephraim Avenue (Camden):

Patients should consult with their health care provider to make sure they qualify for testing. (This site replaces the former Cooper’s Poynt location.)

- Appointment: Yes, but walk-ups of Camden County residents accepted
- Hours: 12 p.m. to 4 p.m. weekdays
- Residency Requirement: Yes, Camden County residents only
- Age Requirement: Age 13+
- Affiliation: This site is a collaboration among Virtua, Cooper and Camden County

New: Dudley Grange Park, 3101 Federal Street (Camden):

Patients should consult with their clinician to make sure they qualify for testing. The clinician then provides the scheduling phone number (856-968-7100) to the patient, who calls directly to schedule the appointment.

- Appointment: Yes, but walk-ups of Camden County residents accepted
- Hours: 8:30 a.m. to 4 p.m. weekdays
- Residency Requirement: Yes, Camden County residents only
- Age Requirement: Age 13+

- Affiliation: This site is a collaboration among Virtua, Cooper and Camden County

Virtua Health & Wellness Center - Moorestown

Residents of Burlington County with active COVID-19 symptoms do not require an appointment for testing; all others must have a referral from a Virtua-affiliated physician.

- Appointment: Yes, but walk-ups of Burlington County residents accepted
- Hours: Monday, Tuesday, Friday, Saturday, and Sunday: 8 a.m. to noon; Wednesday and Thursday: closed
- Residency Requirement: Yes, Burlington County residents only
- Age Requirement: Age 13+
- Affiliation: Virtua

Rite Aid (Barrington): Self-swab site overseen by Rite-Aid pharmacists.

- Appointment: Yes
- Other Requirements: Must be 18 years or older. Drive thru and self-swab. Must be a healthcare facility worker; first responder; age 65 and older; or have comorbid conditions

- Referral: Requires registration via Google account at <https://www.riteaid.com>
- Residency Requirement: No
- Affiliation: Partnership between Rite Aid and U.S. Department of Health & Human Services

CVS Pharmacy Test Sites (as of Friday, May 29)

Pediatric Testing

There are no dedicated COVID testing centers for pediatric patients. Parents who call the Virtua Access Center are encouraged to speak to the child's pediatrician. The Virtua Access Center can then guide callers to the county website where they live. The Burlington County testing center in Westampton will test children with an appointment.
